# HUGAU OBLI 2028 OUR NEW FIXED MATURITY BOND FUND IS OPEN FOR SUBSCRIPTIONS STARTING ON OCTOBER 12, 2023

Last spring, we announced our plan to create a new fixed bond fund maturing in 2028, and today we are delighted to inform you that Hugau Obli 2028 was approved by the AMF on 09/12/2023.

Subscriptions are open from now on, weekly, every Friday before 10:30 AM

Target performance: 6% annualized

Why launching it now? The rise in long-term rates is accelerating on both sides of the Atlantic. In September, the sharp rise in the price of crude oil, the slow pace of disinflation and the persistent risks posed by rising wages in resilient labor markets, are causing the yield curves to flatten. The inversion is attenuating, but not as wished, by the decrease in short-term yields, but by the increase in long-term ones. Launching Hugau Obli 2028 in such an environment represents a real investment opportunity.
